- Request articulation within three years of high school graduation date;
- Furnish official copy of high school transcript indicating Applied Engineering Technology program completion;
- Satisfactorily complete the program with a B or better in the program courses;
- Must matriculate 15 credits of coursework at Hillsborough Community College on either a full or
  part-time basis to have these articulated credits noted on student's official college transcript.
